Re: 2025 Plowing Competition Waiver

Plowing Competition Waivers are mandatory for all Plowing Competitors competing in any Plowing Competition in Ontario (including Branch Matches, Junior Matches, Coaching Days and the International Plowing Match & Rural Expo).

To simplify this process, all Plowing Competitors must submit one signed copy of this waiver to the OPA Office. This signed waiver will then qualify them for all sanctioned Plowing Competitions in Ontario. The deadline for completed waivers is August 1st, 2025 (or as soon as possible).

A master list of Plowing Competitors who have signed the Waiver will be emailed to Branch Secretaries in advance of their local Match. Secretaries will have blank waiver forms to be used in any instance where a competitor's name is not on the master list.

Plowing Competitors WILL NOT be allowed to compete without a signed waiver.

All waivers must be signed by a witness in order to be accepted.

IMPORTANT – The waiver is not an insurance certificate.

ALL Plowing Competitors must also show a copy of their insurance certificate at every Match (that shows a minimum of \$2 Million liability coverage and is signed by a company representative).

Competitors who do not show a valid insurance certificate cannot be permitted to plow.
